## Data Notes

- ❖ Total drug overdose deaths are defined as those in which drug poisoning (overdose) (ICD-10 X40-X44, X60-X64, X85, Y10-Y14) was the underlying cause of death.

Drug overdose deaths involving opioids are a subset of total drug overdoses in which opioids (ICD-10 T40.0-T40.6) were reported as being involved in the deaths.

Drug overdose deaths involving heroin are a subset of total drug overdoses in which heroin (ICD-10 T40.1) was reported as being involved in the deaths.

Drug overdose deaths involving prescription opioid pain relievers are a subset of total drug overdoses in which prescription opioid pain relievers (ICD-10 T40.2-T40.4) were reported as being involved in the deaths.

- ❖ Causes of death are reported to the Department on death certificates by county coroners, medical examiners and physicians.
- ❖ Final data are considered complete, having been reviewed and cleaned. Provisional data are tabulated from records in the process of being reviewed and cleaned and where reporting may not be complete. The provisional figures in these tables represent the death records in the Department's Illinois Vital Records System (IVRS) as of the report date listed at the top of the page.
- ❖ Decedent race and ethnicity information is not coded until near the end of the reviewing and cleaning process. Therefore, this information is not available for provisional years.
- ❖ Estimated completion dates for finalizing provisional years are as follows:
  - Provisional 2015 made final by December 2016
  - Provisional 2016 made final by July 2017
