Candidates Must Satisfy the Following Requirements:

Education and Licensure Requirements

- ✓ (a) graduation from an approved nursing education program resulting in an associate or a diploma degree in nursing and three years of professional nursing experience **or**, (b) a bachelor's degree in nursing and two years of professional nursing experience **or**, (c) a master's degree in nursing.
- ✓ Licensure as a Registered Nurse in the State of Illinois.

Knowledge, Skills and Abilities

- ✓ Thorough knowledge of federal, state and agency laws, rules and regulations concerning licensure and certification of health care agencies and facilities.
- ✓ Thorough knowledge of nursing principles and practices.
- ✓ Ability to prepare accurate reports of survey findings.
- ✓ Ability to develop and maintain harmonious and productive working relationships with various administrative and medical personnel, local governmental agency personnel and recipients of health care programs.
- ✓ Ability to travel independently.
- ✓ In addition to English verbal and written skills, candidates may be required to translate, speak and write a foreign language at a colloquial skill level. Some positions may require manual communication skills.
