	<ul> <li>Board positions still pending         <ul> <li>Illinois Critical Access Hospital Network (ICAHN)</li> <li>Child Advocate Group</li> </ul> </li> <li>Other organizational reports/updates:         <ul> <li>SafeKids – Amy Hill forwarded a report identifying that: SafeKids coalitions throughout the state have received funding from State Farm to implement car seat safety check-up programs; AAA has funded two SafeKids coalitions in Illinois to promote car seat safety; Water safety groups continue to promote awareness of the amendment to the Illinois School code which requires water safety education in grades K-6; SafeKids Chicago at Lurie Children's received funding for a firearm safe storage program, and will distribute firearm trigger locks and storage safes with education.</li> <li>Child Maltreatment Toolkit, 3<sup>rd</sup> Edition, 2025 – Sue Fuchs provided an update on this resource which was originally developed by Illinois EMSC to serve as a guide/resource when managing the clinical and psychosocial needs of children presenting to the ED with suspected child abuse/neglect. Through grant funding, Lurie Children's took on the responsibility to create a 3<sup>rd</sup> Edition of this document and has expanded the contents, added new resources, and worked to ensure consistency with current practice standards. Advisory Board SPOTLIGHT	Organizations represented on the EMSC Advisory Board are provided an opportunity to present their programs or organizations. Highlighted at today's meeting was LaRabida Children's Hospital. Theresa Martinez reviewed the history and provided an overview of services provided at LaRabida Children's Hospital and the children that it serves. Theresa discussed their inpatient, outpatient, and wrap around services, including their acute rehabilitative services. LaRabida also serves as a child advocacy center and conducts forensic interviewing; provides services for children who have been abused, neglected or experienced trauma; are a system point of entry for early intervention services for the Southeast Chicago area; provides mental health assessments for children entering DCFS custody. IDPH, Division of EMS & Highway Safety Report	<ul> <li>Division of EMS report (Kelly Jones/Evelyn Lyons)</li> <li>■ EMSC staff changes – Evelyn confirmed that she is retiring as the EMSC Manager effective 12/31/2024 after serving in this role for 30 years. She noted that its been an honor to be part of such a collaborative effort, and conveyed thanks for all the generous assistance that EMSC advisory board members and committee members have lent over the years. Evelyn will still work with EMSC on a part-time basis thru a contract with IDPH. Kelly will cover the EMSC Manager responsibilities in the interim until the position is filled.</li> <li>■ Division Update Report</li> <li>○ The Division's Administrative Rules were adopted on November 1, 2024. System plan amendments are due prior to August 1, 2025</li> <li>○ The pass rate for the NREMT EMT examination in Illinois at first attempt for the second half of the year is currently 72%. This day last year, it was at 59%.</li> <li>○ The EMT Training, Recruitment and Retention Task Force, established through legislation, continues to meet, and will submit a report to the general assembly including findings and recommendations.</li> <li>○ IDPH Stroke Hospital Designation Count is ASRH (79); PSC (59); and CSC (18). In September, Advocate Illinois Masonic Medical Center was accredited as a Primary Stroke Center Plus.</li> <li>○ EMS staff are currently processing licensing requests within 2 weeks from the date the department receives the application or renewal.</li> </ul>	FYI

	<ul> <li>The IDOT quarterly report submission has changed and will now be submitted in Amplifund.</li> <li>Trauma Registry is no longer accessible through the DPH portal, but through the Trauma Coordinators SharePoint. This has been communicated via the Trauma Community listserv.</li> <li>Illinois Critical Access Hospital Network (ICAHN) grant project update – IDPH has been providing grant funding thru the EMSC partnership grant to ICAHN to support pediatric emergency care education and training for critical access hospitals, who serve as safety nets for their communities. This includes online webinars on topics such as pediatric readiness and managing the needs of pediatric patients with respiratory distress, and those with behavioral health issues. On October 25<sup>th</sup>, Nicolena Mitchell (Colorado EMSC) and Kelly Jones (Illinois EMSC) co-presented on Pediatric Readiness to the critical access hospitals. An upcoming webinar by national presenter Jermaine Galloway, known as TallCop, on the recognition and current trends of drug and alcohol abuse among teens, will be held on December 12. Also, in-person mock code/simulations will be offered at a January ICAHN conference and supported by OSF Children's Hospital and Cardinal Glennon Children's Hospital. ICAHN continues to work with the CAHs to identify a Pediatric Quality Coordinator and Pediatric Physician Champion at each of the CAHs.</li> <li>EMS Administrative Code updates - Revisions to the EMS Administrative Rules were adopted on Nov 1, 2024, and include a number of pediatric updates as reviewed at previous board meetings. Communication regarding these changes are being shared with hospital Pediatric Quality Coordinators, EMS Systems, EMSC committees, prehospital and hospitals stakeholders, and others. A summary of all pediatric/EMSC changes are outlined in a 6-page handout that was distributed to board members at this meeting.</li> </ul>	FYI
EMSC Advisory Board Bylaws	Evelyn reviewed the EMSC Advisory Board bylaws which were last updated in 2022. Based on updates to the EMS Administrative Code and the need for other changes, the following edits have been made to the bylaws: Article I – the trauma manager representative will be recommended by the State Trauma Advisory Council since the Illinois Trauma Coordinators Coalition no longer exists; the Illinois EMT Association name has changed to the Illinois EMS Association; and the Illinois Fire Fighters Association name has changed to the Associated Fire Fighters of Illinois; Article V, 5.2 – a new sentence was added "Meetings may be conducted in-person with virtual capabilities or may be held by virtual capabilities only."; 5.13 – a typo in the word "authenticated" was fixed; Article 9.17 was deleted since it outlined the EMSC Prevention and Public Education Committee, which no longer exists - subsequent bullets were re-numbered. A motion to approve these changes was made by George Paul and seconded by Sue Fuchs. All were in agreement and the motion was approved by the board.  The board was asked if the Child Advocate Group should remain as a board position since it has been vacant for several years, and it has been difficult to identify a statewide group to serve in this role. Currently SAFEKIDS and The Arc of Illinois serve on the board and are considered child/family advocate groups. The board felt that its important to keep this role. Recommendations should be forwarded to EMSC regarding potential organizations that could serve in this role.	Evelyn will update the bylaws as noted, and the revised bylaws will be posted on the EMSC website.  Board members are asked to assist in identifying a statewide child advocate group that could serve on the board.
PCCC/EDAP/ SEDP Updates	Kelly Jones provided the following updates:  Regions 4 & 5  Follow-up virtual visits were conducted at a few hospitals  Approval letters are being sent out.  Region 11  Site visits began in November and will conclude on 12/11/2024.  One new PCCC application has undergone review, and a site visit was recently conducted.	FYI

	<ul> <li>One hospital requested an application extension, and their application will be due in January 2025</li> <li>Regions 1 &amp; 10</li> <li>Their renewal educational sessions were conducted in September</li> <li>Renewal applications are due January 17, 2025</li> <li>Site visits are anticipated May/June 2025</li> <li>Current participation in pediatric facility recognition (106 hospitals)</li> <li>PCCC/EDAP level = 11; EDAP level = 83; SEDP level = 12</li> <li>A new EMS Resource hospital will be submitting an EDAP application soon; and there are a few hospitals that have expressed interest in submitting an initial application.</li> <li>Regional QI Committee reports/updates – key highlights</li> <li>All regions are continuing work on their projects, and several have begun to identify new topics/conditions to monitor in 2025.</li> <li>The Region 9 co-chairs conducted a presentation on their regional pediatric quality improvement initiatives at the Midwest EMSC Annual Emergency Department Symposium that was held yesterday. The presentation on their pediatric pain quality monitor involved 14 hospitals, was well received and can serve as a model for other states.</li> <li>Region 11 will have a change in their chair. Mo Otting will mentor Barbara Villanova and Tes Gonzaga-Reardon as they transition into the new co-chair roles.</li> </ul>	FYI
Federal EMSC Updates	<ul> <li>Evelyn Lyons discussed the following:</li> <li>She is currently working on the HRSA State Partnership Grant non-competing continuation progress report which is due on December 17, 2024.</li> <li>Individual state reports are still pending for the 2024 Pediatric Readiness online survey of all EMS agencies in U.S. that respond to 911 calls. The assessment data is undergoing analysis by the EMSC Data Center (EDC) in order to develop reports for each state. It is anticipated that the reports should be available in early 2025. Our state participation (46%) matched the National participation (46%).</li> <li>Annual Midwest EMSC Pediatric Symposium – State EMSC programs in the Midwest have joined together each year to conduct pediatric educational symposiums with timely topics. A Prehospital Symposium was conducted on October 29th and provided attendees with CE certificates for 4.25 hours (topics included respiratory emergencies, human trafficking, obstetric emergencies),. An Emergency Department Symposium was held yesterday (December 5th) and focused on pediatric quality improvement focus, with national and local speakers (the Region 9 co-chairs presented as well as speakers from Lurie Children's Hospital).</li> </ul>	FYI
Committee Updates	Committee chairs provided the following updates:  **Pediatric Prehospital Committee (Amy Crane/Myto Duong)**  **2024 Pediatric Prehospital Protocol manual – the new edition has been finalized and is now posted on the PublicHealthLearning website. It was also emailed to EMS System Coordinators and other EMS stakeholders.  **State Prehospital Agency Pediatric Recognition Program – grant funding will support a temporary contractual position thru UIC to kickstart the development of the requirements, guidelines, resources and other activities necessary for an EMS Agency Pediatric Recognition program and then to pilot the process at a few agencies in our state. Interviews are being scheduled and a contractor is anticipated to be on board in January. The national prehospital consensus minimum criteria is currently under review by Federal EMSC/HRSA program. 	<ul> <li>Facility Recognition Committee (Patrick Dolan/Kelly Jones)</li> <li>National EMSC Collaborative projects – Currently the Pediatric Readiness Quality collaborative began in June 2023 and runs through December 2024. It allows hospitals to choose from one of the following pediatric focus areas: patient safety, patient assessment/reassessment, pain management, and suicide. Three Illinois hospitals are participating. A couple of regions are exploring applying to the NPRQI to support their regional quality project in 2025. In addition, the Disaster Response Collaborative began in September 2024 and transitioned from the Disaster Networking Collaborative. Several hospitals in Illinois are participating and are working on projects within this collaborative.</li> <li>Pediatric Readiness Recognition Program Collaborative (PRRPC) – As noted in the Pediatric Prehospital Committee, the minimum criteria is under review by the Federal EMSC/HRSA program. This collaborative defined minimum and "stretch" criteria for both hospital and prehospital agency recognition programs.</li> <li>The proposed statewide pediatric quality improvement monitor project that will focus on abnormal vital sign assessment/reporting/reassessment received IRB approval in November. Hospitals that choose to participate will complete memorandums of understanding. Patrick Dolan is working with Myto Duong to structure the data collection for this QI project through Southern Illinois University.</li> <li>Pediatric Preparedness Workgroup (Teresa Riech/Cassandra "CJ" Morris)</li> <li>Hospital Site Visits – The disaster assessment components of the PCC/EDAP/SEDP site visits are now back to being conducted in-person. Since COVID, they have conducted virtually. Having them integrated once again during the in-person site visits greatly enhances the ability to capture information and work more collaboratively with the hospital emergency management personnel.</li> <li>Educational module reviews – The following EMSC educational mo</li></ul>	FYI
