#### **AGENDA ITEMS**

#### Call to Order & Roll Call

### Review/Approval of Minutes from February 2025

The agenda was reviewed. February 2025 Minutes were reviewed and accepted. Motion: 1<sup>st</sup> Jawad J., 2<sup>nd</sup> Bree A., the group unanimously approved.

### **Updates: Illinois Department of Public Health (IDPH)**

- Budget updates- no new updates at this time. We will share information as it becomes known to us.
- Staffing changes at IDPH: Currently in the interview process for the Perinatal Nurse Lead position.
- 640 updates: Currently with the policy advisor. Hoping to move forward in May and have additional updates in June.
  - Next step after the Policy Advisement team approves is sending to the Governor's Office
- Maternal Health Blueprint updates:
  - Moving through the Governor's Office. Anticipate a release soon.
- IDPH Maternal Health Summit- November 18-19 of 2025 at the ISU Bone Center.
- IL DOPP Program letter: currently double-checking language and program accessibility following newly announced budget cuts. Awaiting word from program partners.
  - ILPQC desires to send out information and remain consistent.
- LOC Map created by Cara Bergo can be found on the IDPH site- Perinatal Regionalization

### **Old Business**

- Continued discussion on West Suburban Hospital
  - Mark L. lead the discussion, gave a recap of his presentation from February.
  - What role can PAC play in the future with policy and action?
  - Consider and discuss public health models that elevate midwifery care. Indiana has an effective model to assess, as they experience maternity deserts as well.

### **New Business**

- Assisted Ventilation
  - Discussion on assisted ventilation and what is expected at all levels.
  - The need is there to discuss assisted ventilation. Topics of discussion included-
    - When is bi-flow nasal cannula support considered assisted ventilation?
    - Personnel expectation when level I or II are

- providing AV.
- When patient needs AV, what is the expectation when needed for 6 hours- transfer at the 6-hour mark? (Call neo and discuss the case to determine next steps)
- Discussion is opened to anyone who should oppose a new definition.
  - Some did oppose, and the discussion continued regarding challenges and respective level of care of the hospital.
  - Looking to find the medium, and direction is to always call the APC to consult if on >2L for over 6 hours. Transfer or create a care plan to keep the infant. Considerations should also be taken when discussing separating mom and baby.
- PAC needs to approve the drafter letter on AV via a vote.
  - After a vote, the letter will go to the Director's Office, then to legal, and lastly IDPH and disseminated to the hospitals.
- Motion to approve the letter- 1<sup>st</sup> Jawad J., 2<sup>nd</sup> Mark L.

#### **Committee Updates**

### MMRC Update: Last meeting 4/9/2025.

- 2022 cases still under review.
  - Reviewed 6 deaths
    - 5 deaths were found to be pregnancy related and 5 were found to be at least somewhat preventable
    - Cause of death: hypoxic respiratory arrest due to lost airway, Diabetes, Diabetes, Asthma, Stroke
  - o New member vote: Julieta E. Barroeta (pathologist)- 1<sup>st</sup> Mark L., 2<sup>nd</sup> Steve L. Passed PAC.

### MMRC-V Update: Last meeting 3/30/2025

- 2022 cases under review.
  - Reviewed 3 deaths due to substance use, 4 deaths due to domestic violence homicide and 1 death due to suicide.
  - Of the 8 deaths, 4 were found to be pregnancy related and at least somewhat preventable.
  - New member vote: Sherry Jones (OB in southern Illinois, very involved in COVID work) 1<sup>st</sup>
     Robin J., 2<sup>nd</sup> Steve L. Passed PAC.

- ILPQC updates- Upcoming face to face meetings in May
  - Vote on new initiate was approved and can be brought to PAC. IL Statewide Perinatal Quality Initiative
- New member voted in- Leslie Caldarelli

- ILPQC has an in-person conference in May.

### **Hospital Facilities Designation Sub-Committee (HFDSC)**

- Rockford network- Two hospitals moving from II to IIE.
- Peoria Network- St. Elizabeth decrease to level I.
- Loyola network- Alexian Brothers decrease from IIE to II.
- UIC network- Trinity closing in 2029. Opening a new facility, but no OB. IMMT has pushed to keep to hospital open until a new unit is available.
- Alex discussed the Implementation Committee for LOC. We are awaiting 1<sup>st</sup> notice, and interest letters can be sent to Alex or Hillary. Bree A. was the previous chair.
