 - a. [77-245](#), HOME HEALTH, HOME SERVICES, AND HOME NURSING AGENCY CODE—approved for consideration by the full State Board of Health
 - i. Presented by Karen Senger
 - ii. Applying band-aid, rather than wound care, was the compromise with the industry, to ensure that work of home service workers remains preventative rather than therapeutic
 - iii. Physician's assistant would require a collaboration agreement with a physician to issue an admitting order
 - b. [77-545](#), SEXUAL ASSAULT SURVIVORSEMERGENCY TREATMENT CODE—approved for consideration by the full State Board of Health
 - i. Presented by Karen Senger
 - ii. Violent crime vs. forcible felony is not defined in the code

 - iii. GRF funds line items for this program

- iv. Highest prevalence language was pulled from the statute, will consider making “area” plural to avoid limiting it to one single area
 - v. Are there any limits to ensure the money is used for direct services?
 - 1. Fee-for-service is required to be 75% of the budget
 - 2. We also ask for info on percentage of staff time that each person’s salary goes to
 - e. [77-920](#), WATER WELL CONSTRUCTION CODE—approved for consideration by the full State Board of Health
 - i. Presented by Gerrin Cheek-Butler and Chuck Jones
 - ii. Local governments are not required to inspect, so they do not receive all inspection fees
 - iii. Concrete vs. cement tile—there is no difference, used interchangeably (although cement is used to create concrete)
 - f. [77-955](#), HEALTH CARE WORKER BACKGROUND CHECK CODE—approved for consideration by the full State Board of Health
 - i. Presented by Sean Dailey and Allen Griffy
