- One Net training reminder. Complete by 12/21/2025.

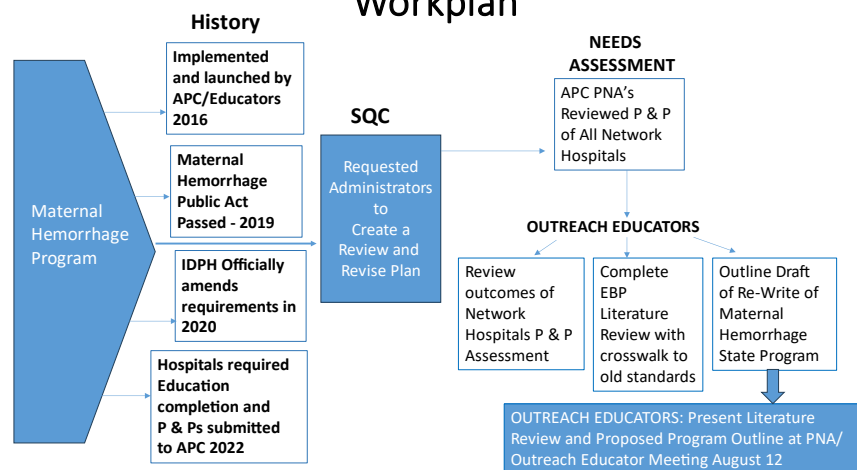

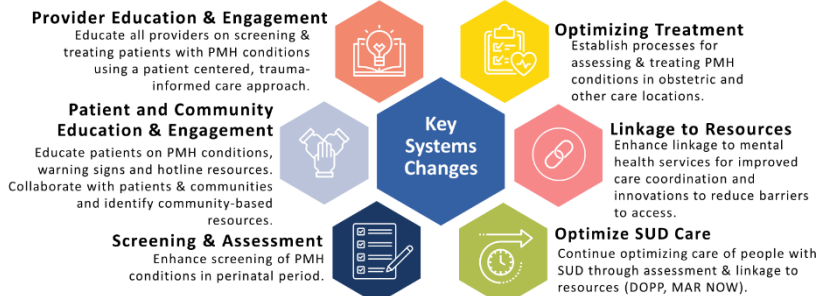
