Call to Order

The subcommittee meeting began at 12:33pm. Roll was taken and the agenda reviewed.

Approval of Minutes

Minutes from the February 1, 2022, meeting was approved. Arden Handler made the motion to approve, Daniel Johnson seconded the motion, and the minutes were unanimously approved.

Agenda Item: Telehealth Visits

Discussion: Information shared with Sub-committee members regarding meeting that occurred with the CNSE group last month. Several members of that group stated they liked the Infographic, but more information concerning what to do if connection is lost or cannot be made should be included, as well as client actions to ensure that the visit is comprehensive.

Action items: Glendean Burton to contact Lee from Sinai, as he agreed to pull a group of clients together to review the Infographic and give us feedback. Need to see recommendations from IMMT TF-Systems committee related to telehealth visits in the latest annual report. Trishna Harris to provide this document to Glendean and Catherine. Literacy review of the Infographic also needs to occur.

Agenda Item: Workplan for 2022

Discussion: Voting results number in order of highest priority: Content and Focus of Care in the 1-year Postpartum Coverage Period; APORS Follow-up; followed by a 4-way tie between SUD Pre and Postnatally, Pediatric Health Deserts, Case Management of Families, and Health Equity Training. Daniel Johnson suggested a priority on pediatrics and go with Pediatric Health Desert as one of the choices.

Action items: Glendean proposed a vote on the 4 items to work on during 2022: 1. Content and Focus Care in the 1-year Postpartum Coverage Period; 2. APORS Follow-up; 3. Pediatric Health Deserts; and 4. Community Violence...Daniel Johnson made motion and Cynthia Wilson seconded the motion, the choices were unanimously approved.

Agenda Item: MiPATH Prenatal Care Recommendations

Discussion: This project incorporates patients' medical, social, and structural determinants of health and preferences to create tailored prenatal visits that would include telemedicine and in person visits. This is still a work in progress.

Action items: Group could use the MiPATH recommendations to strengthen content of Postpartum care.
