The Minimum Data Set dated 3/19/19 documents R201 is severely cognitively impaired and requires limited assistance with bed mobility and ambulation.</p> <p>The Care Plan dated 3/9/18 documents R201 has behaviors of being resistive to care and wandering and that R201 is rarely or never understood.</p> <p>The Progress Note dated 5/14/19 documents "Resident (unknown) notified staff that (R201) was on the floor in (unknown) resident's room, (unknown) resident stated that (R201) entered room and (unknown resident) tried to help (R201) out, (R201) was on the floor on (R201's) back." "Monitoring and neuros (neurological assessments) were initiated."</p> <p>On 10/8/19 at 12:54 PM R201 was wandering in the dining room trying to take food from other resident's plates.</p> <p>The Allegation of Abuse Log dated 2019 documents R201 and R41 had altercations on 5/26/19 and 7/13/19.</p> <p>The Final Report dated 5/31/19 documents on 5/26/19 at 6:00 PM "(R201) approached the desk where (R41) was sitting and laid a clothing protector down to fold it. (R41) attempted to take the clothing protector and (R201) pulled back. (R41) then grabbed (R201) by the collar of (R201's) shirt and right wrist and began to pull (R201) to (R41's) face. (R201) Walked up with a clothing protector and started messing with it by the desk. (R41) tried to take it from (R201) and (R201) got mad and pulled it back. (R41) then jumped up angry and grabbed (R201) by the neck of (R201's) shirt and (R201's) arm. (R41) pulled (R201) up to (R41's) face screaming at (R201) that (R41) was going to hurt (R201). It took me and another CNA (V8) to get (R41) off of (R201)."</p> <p>V8 CNA's written statement dated 5/26/19 documents "(R41) stood up and grabbed (R201) by the shirt near the collar bone and the right wrist and tried pulling (R201) to the ground."</p> <p>V10 Licensed Practical Nurse's written statement dated 5/26/19 documents "I was administering med (medications) to a patient and I heard yelling and screaming-(R41) was being handled by V7 and (R201) was being taken away by V8. (R41) was extremely agitated towards (R201). Mention of hurting (R201) so (R201) would learn a lesson."</p> <p>The Communication Note dated 5/26/19 documents "(R201) involved in altercation with another resident (R41)." and "Monitoring initiated."</p> <p>On 10/09/19 at 10:13 AM V8 stated R41 does not like anyone to mess with R41 while R41 is eating. V8 stated R201 approached R41 with a clothing protector and R41 tried to pull it away from R201 and R201 pulled back. V8 stated R41 then grabbed R201's collar bone and tried to pull R201 to the ground. V8 stated when R41 grabbed R201, R41 was angry and trying to get R201 away from R41. V8 stated R41 was yelling at R201 and usually calls R201 names like "dummy." V8 stated R201 and R41 are on 15 minute checks and staff try to keep them separated.</p> <p>The Progress Note dated 7/5/19 documents on 6/24/19 "(R201) entered another res (unknown resident) room, both residents ended up on the floor" and "New intervention for monitoring to be continuous at this time."</p> <p>The Final Report dated 7/18/19 documents on 7/13/19 at 8:30 am "(R41) walked by the couch in common area where (R201) was sitting. (R41) pointed a finger at (R201) and said, "Go ahead, keep doing it, and just see what happens." (R201) stood and muttered to (R41) and either had (R201's) hand near (R41's) face or was poking at (R41's) chest. (R41) states "Stop hitting my face." (R41) and (R201) then grabbed onto each other's arms and (R41) pushed (R201) to the floor. V13 stated R201 did not hit R41. V13 stated R41 grabbed R201 and put R201 on the ground. V13 stated staff surrounded R201 and R41 kicked R201. V13 stated R41 purposefully pulled R201 down to the ground. V13 stated R201 will walk up to the desk where R201 sits and mess with R41's papers. V13 stated R41 snaps the papers out of R201's hands and tells R201 to stop. V13 stated R201 starts chattering and that irritates R41. V13 stated "they are like two negatives together -they clash - they are not good for each other." V13 stated if staff see R201 and R41 going towards each other they try to redirect R201.</p> <p>On 10/9/19 at 2:00 PM V11 Registered Nurse stated on 7/13/19 R201 was sitting calmly on the couch when R41 approached R201. When R201 stood up R41 grabbed R201 by both of R201's arms and shoved R201 to the ground. V11 stated while staff were trying to get R41 away from R201, R41 kicked R201. V11 stated R41's intent was to push R201 down. V11 stated R201 was upset and startled. V11 stated R41 was more agitated and regretful than upset. V11 stated at that time R41 knew right from wrong and R41 thought R41 was in trouble. V11 stated R41 is a former police man and thinks R41 is the police of the unit.
