

Free Opioid Educational Video for Your Training Programs



In the effort to assist all new Illinois medical and dental prescribers receive training regarding opioids, IDPH and the Office of the Illinois Attorney General developed this 15 minute training video to provide guidance for new prescribers to...

1. Screen for opioid misuse and use disorder
2. Monitor patients on opioids
3. Use the Illinois Prescription Drug Monitoring Program

Frequently Asked Questions

1. Why is this training being offered?

Opioids are among the most commonly prescribed medications, although literature suggests many prescribers are not comfortable with principles of pain management. This training is being offered to provide prescribers in Illinois with tools that can be used to help them manage patients taking opioid medications and to assist in safe prescribing practices to prevent opioid abuse.

2. Who is the target audience?

Our target audience is residents and fellows in medicine and dentistry but the video is certainly appropriate for students. We welcome physicians in practice, nurse practitioners, and physician assistants and other health care workers to view and use the video.

3. What topics are covered in the video?

1. Best practices in pain management adapted from CDC guidelines
2. The Illinois Prescription Monitoring Program

4. When should residents and fellows view the video?

Consideration should be given to using the video as part of the orientation/on-boarding of new prescribers. However, the video can be integrated into training programs and medical and dental school as deemed appropriate by faculty.

5. Is this video training required?

No. Use of this video for your training programs is voluntary; however, we encourage you to implement it given the severity of the opioid crisis affecting our state.
