7	<p>Discussion by members regarding the proposed rule changes: Anita suggested to broaden the definition of ACIP and tie it to CDC; Rashmi expressed concern and asked that verbiage be changed for meningococcal to read " The first dose shall have been received on or after the 10<sup>th</sup> birthday, and the second or most recent dose shall have been received on or after the 16<sup>th</sup> birthday, at least 8 weeks after the first dose" This would add "or most recent" and "on or after the 16<sup>th</sup> birthday". It was stated that the meningococcal issue was under further review.</p> <p>There was further discussion on the religious exemption form and the reluctance of physicians to sign the form. A suggestion was made to add verbiage to the form stating the physician refused to sign the form to allow for school entry. Linda G. asked what the committee was endorsing and why it couldn't be discussed at the meeting on 11/16/2016 in Chicago and what was the purposed of 2<sup>nd</sup> notice. Dr. Shah responded with an explanation of the entire rule making process and at what point it goes to JCAR for approval. He added additional comments that we wanted to ensure a quorum at the meetings in order for the rules to move forward and we couldn't guarantee a quorum at the 11/16/2016 meeting.</p>	IAC Committee
