Introductions and Welcome

- Raye Ann called the meeting to order and went around the room and on the phone doing introductions.

Minutes

- The minutes from December 2017 were reviewed and approved with a unanimous yes.

Agenda Items

1. IDPH Update

- The Illinois Department of Public Health gave an update on the upcoming levels of care combined meetings:
 - o January 24th a combined meeting of the Levels I and II and Levels III and IV will take place as well as a discussion on the AWHONN staffing guidelines.
 - o March 1st a combined meeting of the Levels of Care groups with the Hospital Facilities Designation Committee.

2. Maternal Level I

Transfers

- Discussion on a list of resources that would be ideal for a hospital to have in regards to inpatient management, outpatient management, and for the morbidly obese.
- Discussion on whether a list should be mandated or left up to the hospitals discretion with soft guidelines.
- Deborah Boyle presented a list of resources that a hospital might not think of when providing care for obese mothers (Over 50 BMI)
- Discussion on if each hospital should be asked to come up with a BMI cut off? The idea was to have the policy go through and approved through the perinatal center.
- Discussed:
 - Having a resource checklist as a guideline for hospitals
 - Ask the individual hospitals to write their own protocol to be confirmed with the perinatal center
 - Consults would be recommended for BMI 50 and above.
- Possible separate meeting on what should be a consult versus what should be a transfer.

- Discussion surrounding doctors who work across multiple/different levels of care facilities.
- Action Item: Deborah and Bob to figure out a list of what should be a consult and what should be a transfer.
- This group recommends that the Levels of Care: Levels III and IV group to look at having bariatric services.
- Public Comment: Make sure that appropriate training for the nursing staff is in the language.

3. Homework and Next Steps

- Continue the Maternal Level II.
- Discussion and review of a potential list of when to consult based on BMI.

4. Public Comment

- Asked if the group plans to discuss doulas at some point.
- It was also asked that the group keep in mind incarcerated women and who would be able to visit during delivery.
