The Center for Minority Health Services (CMHS) was created, by statute, as a vehicle for implementing change. It is designed to assess the health concerns of minority populations in Illinois and to assist in the creation and maintenance of culturally sensitive programs. To achieve this goal the Center works within IDPH and with other relevant state and local entities to heighten awareness of minority health issues and services across the state.

Mission

To eliminate health disparities for Illinois' racial and ethnic minorities through capacity building, workforce development, strong health policies, and implementation of culturally and linguistically appropriate programs.

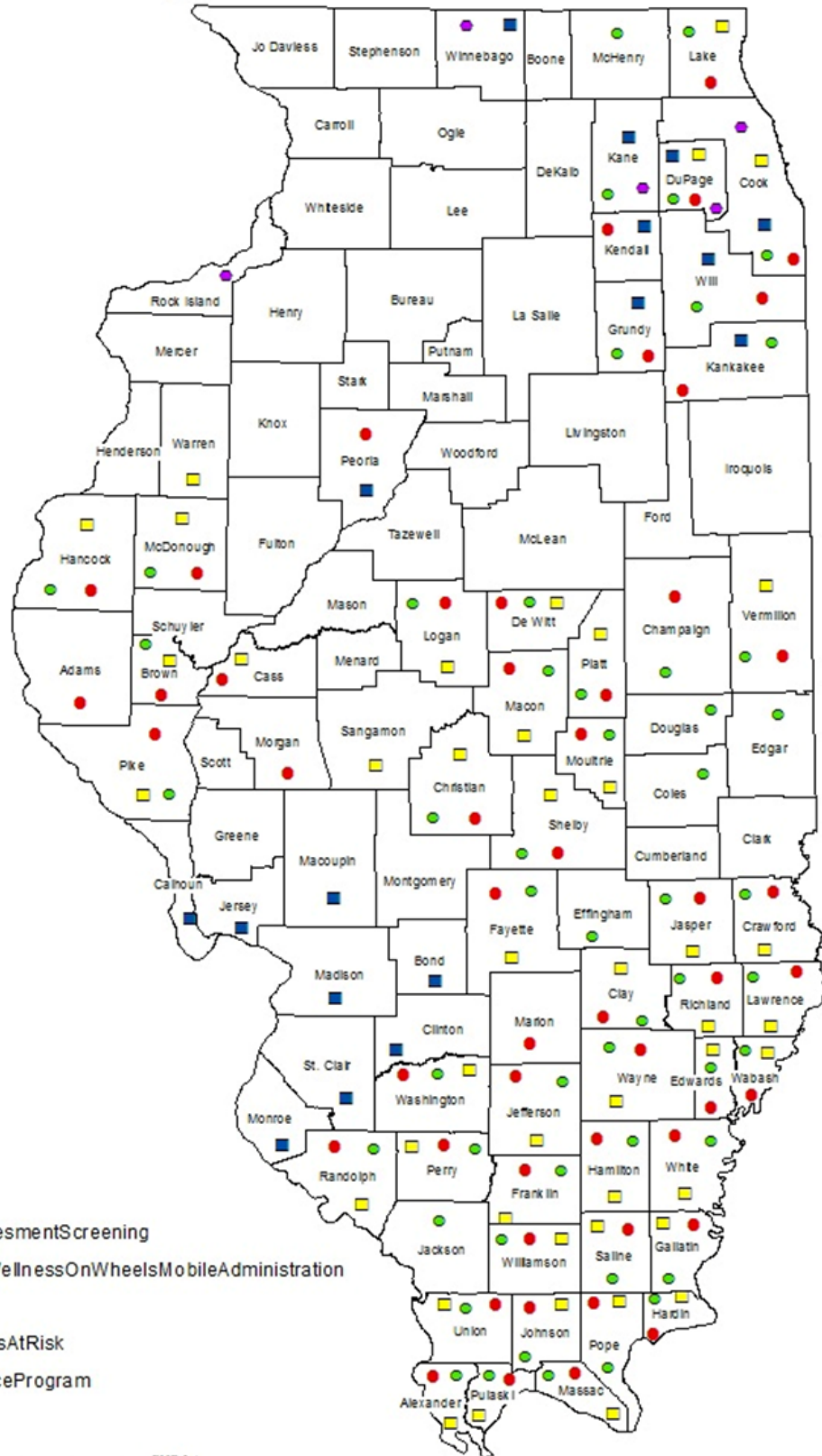
Vision

PROGRAM OVERVIEW

CMHS works with various stakeholders including local health departments, Federal Qualified Health Centers (FQHCs), social service organizations, community-based programs, faith-based congregations, foundations, and associations throughout the state, to provide outreach, education, access to health care, and other wrap-around services for Illinois' most vulnerable residents. All programs administered with funding from CMHS are culturally and linguistically appropriate for the targeted population. All grantees must implement the National Standards for Culturally and Linguistically Appropriate Services guidelines (CLAS Standards) in all funded activities. CLAS standards are intended to advance health equity and improve the quality of service, for Illinois' diverse populations.

Minority AIDS Initiative-AIDS/Drug Assistance Program (ADAP) – Budget \$406,000.00

This program provides linkage into ADAP and other drug assistance programs for HIV positive minority individuals who are disproportionately affected by the HIV/AIDS epidemic

through innovative means. By initiating, modifying, or expanding education and outreach, grantees are able to link individuals with unmet medication needs to ADAP services. The program targets low-income racial and ethnic minorities including women, young adults, men of color who have sex with other men, the homeless, uninsured and underinsured individuals, those recently released from correctional institutions, and people with a dual diagnosis of chemical dependency.



Refugee Health Assessment Screening – Budget \$726,444.00

This program is designed to identify individuals with refugee status who have health conditions not observed during or developing after their overseas exam. The program initiates appropriate immunizations, ensures refugees with identified problems are referred to primary and/or specialty care; eliminates barriers to successful resettlement, and protects the health of the community at-large.

This program provides culturally and linguistically appropriate services that include: health education and promotion, nutrition, interpretation, mental health wellness, and medical case management services. These services complement the initial health screening assessment of newly arriving refugees to the State of Illinois.

This initiative is funded through State of Illinois General Revenue, for HIV prevention, education, testing, risk reduction interventions, and care programs targeting communities of color. The funding supports programs with the capacity to reach special at risk minority populations including but not limited to, men who have sex with men, and individuals who are transgender, homeless, ex-offenders, sex workers, those with a history of mental illness or substance abuse, and other difficult to reach populations. This program supports linkage to other services such as housing, food, medication, transportation, appointment reminders, and employment assistance. These services are necessary to address unique problems that many of these individuals may face, placing them at a greater risk for acquiring HIV disease.

Illinois Hepatitis B Outreach, Awareness, and Education to Immigrants – Budget \$458,400.00

The main focus of this funding is to provide outreach, awareness, and education to foreign born Asian and African Immigrant and Refugee Communities regarding Hepatitis B and referral and linkage opportunities for screening, vaccination, and treatment services. These specific efforts are necessary because many of these individuals are at a greater risk of contracting Hepatitis B infection. Higher rates of chronic Hepatitis B infections exist particularly among foreign born populations from Asia and Africa.

This initiative provides preventative health screenings that occur in an innovative and culturally and linguistically appropriate manner throughout the medical underserved areas of Illinois. Funded services are provided in non-threatening environments, and offer culturally and linguistically appropriate services and materials that are reality based, and tailored to ensure relevance to the circumstances and conditions of the target population. Services can be provided in partnership with the Wellness on Wheels mobile units or as a standalone service.

This initiative allows culturally competent and linguistically appropriate services to be offered where, and when the clients need them, with the option for immediate adjustments based on input from clients, disease outbreaks, and special community events. There are currently four Wellness on Wheels mobile units in operation. While the mobiles are housed in Chicago, Springfield (2), and Carbondale, they provide services on a statewide basis. Each air conditioned unit has two intake areas; a small waiting area; a large examination room equipped with exam table, hot and cold running water, storage space, small refrigerator; electrical outlets, and a handicap accessible bathroom.

CMHS is working with Walgreens and community organizations to bring free flu

clinics into rural and underserved communities, and to underinsured and uninsured individuals in Illinois. Through our collaborative efforts, eleven flu clinics were held around the state this year. **Race, Insurance Status and Age were recorded if provided by participant.*

As of this report, 265 individuals have received the life-saving flu vaccine at no out-of-pocket cost to them. Many of the recipients reported receiving the flu vaccine for the first time this year. We will continue to work with Walgreens and community partners to schedule clinics throughout the flu season.

Love to Love Your Heart Initiative

The Love to Love Your Heart is an initiative conducted in partnership with faith-based communities. The goal of the Love to Love Your Heart initiative is to prevent

heart attacks and stroke through education; to provide awareness trainings regarding cardiovascular risk factors including focus on high blood pressure; and to promote nutrition and healthy activities that support heart health.

IDPH Health Equity Council

CMHS coordinates activities of the agency's Health Equity Council (HEC), which recently re-launched in 2017. The

HEC is comprised of 23 diverse representatives from every IDPH Office. The charge of the HEC is to support a work culture within IDPH, that promotes health equity and eliminates health disparities through increased coordination with leadership, programs, and strategic partnerships. HEC work is focused around three priority areas:

- Develop a health equity self-assessment tool for use by IDPH staff and programs
- Support a culturally competent workforce and development of department-wide standards to enhance health equity and as it relates to the mission, vision, values, and priorities of IDPH
- Promote state-wide efforts and support public health partners on research and evidence-based best practices related to reducing health disparities

One of our strategic priorities is to cultivate a diverse workforce. Our office participates in the



internship opportunities that IDPH offers. Most internships are unpaid and open to college students looking to fulfill course requirements or gain practical experience over summer breaks. In addition, we participate in two- year paid internships through the Graduate Public Service Internship program at University of Illinois at Springfield. In FY 17, CMHS hosted 6 interns – 1 doctoral and 5 master’s degree candidates.
